### **EXECUTIVE SUMMARY**

This Instruction continues a Regional Emphasis Program (REP) for programmed health inspections of general industry establishments in industries that commonly have noise and respiratory hazards.

Workers employed in general industry establishments face noise hazards that can lead to hearing loss. The intent of this Regional Emphasis Program is to encourage employers to take steps to address hazards, ensure OSHA evaluates facilities to determine if the employer complies with all relevant OSHA requirements, and help employers to correct hazards, thereby reducing the potential injuries to their workers.

This instruction proposes to accomplish this through outreach and enforcement activities. Outreach activities included a region-wide news release to media, notifying employers of the continuation of the emphasis program. In addition, Region VII federal Area Offices make information about this program available during speeches to any audience with possible connections to affected industries.

- **I. Purpose.** This Instruction continues a Regional Emphasis Program (REP) for programmed health inspections of general industry establishments in industries that commonly have occupational noise and respiratory hazards exposure which is causing or likely to cause injury, illness, permanent disability, or death.
- **II. Scope.** This Instruction applies to general industry establishments in industries that commonly have occupational noise and respiratory hazards within the jurisdiction of all Federal Area Offices in Region VII.
- III. Expiration Date. This Instruction will expire September 30, 2024.
- **IV. Action.** OSHA compliance personnel shall follow the procedures contained in this Instruction when conducting outreach and enforcement activities.

- VII. Action Offices. Region VII Federal Enforcement Offices
- VIII. Background. Approximately 30 million workers experience exposure to hazardous noise on the job. Noise induced hearing loss is one of the most common occupational diseases and second most self-reported occupational illness or injury. Work-related hearing loss continues to be a critical workplace health and safety issue.

Under previous and currently used systems to select high hazard establishments for programmed inspections, the priority for general industry inspections relies on the Bureau of Labor Statistics (BLS) Days Away, Restricted or Transferred (DART) rates in addition to Days Away From Work, Injury, and Illness (DAFWII) rates. The nonfatal occupational

injury and illness DART rate for private industry is 1.5 (2017). BLS hearing loss rates for the Manufacturing Industry Sector is 8.4 (2017).

Initiation of REP development occurred when analysis revealed there were nine North American Industry Classification System (NAICS) codes in the top 15 most cited groups for both 1910.95 and 1910.134. Employees of these Industry Groups could be at risk for both hearing loss and respiratory illness or injury.

This REP has effectively outperformed the average of all health inspections from FY 2016-April 8, 2019. This REP realized a Serious, Repeat, or Willful Violation Rate of 59.1%, which was 9.6% higher than all health inspections. Expectedly, the Average Violation per Inspection favored this REP when compared to all other health inspections with 3.15 compared to 2.82 violations per inspection. Inspections conducted under this REP realized a 3.1% higher initial penalty compared to all health inspections. During this period, 27.1% of hazards cited under this REP were for violations of the Occupational Noise Exposure standard or Respiratory Protection standard. In health inspections not coded for this REP, 13.9% of hazards cited were for violations of the Occupational Noise Exposure standard or Respiratory Protection standard. This REP realized a greater percentage of cited hazards of the Occupational Noise Exposure standard and Respiratory Protection standard than other health inspections combined.

This REP has contributed to personal industrial hygiene sampling in 85 inspections from FY 2016 – April 8, 2019. This REP realized an overexposure to the noise permissible exposure limit (PEL) in 17.5% of these inspections. This REP also realized an overexposure to respiratory PELs in 16.7% of inspections, to include methylene bisphenyl isocyanate, iron oxide fume, particulates not otherwise regulated (PNOR) total dust, PNOR respirable fraction, copper fume, respirable crystalline silica, and hexavalent chromium.

In order to make efficient use of OSHAs limited industrial hygiene resources, focusing them on industries that commonly have both noise and respiratory hazards, this REP is continued. As per CPL 02-00-051 (Reference D.), this health-hazard targeting program includes industries with ten or fewer employees.

- **IX. Inspection Scheduling and Site Selection.** Using the Industry Profile for OSHA Standard 1910.95 (FY 2008) and the Industry Profile for OSHA Standard 1910.134 (FY 2008) from OSHA's Information System (OIS), Region VII developed a list of NAICS Industry Groups.
  - A. <u>Health Hazard Industry NAICS List</u>. The Industry Profile for an OSHA Standard identifies those Industry Groups, which have had citations for that OSHA Standard issued within a specific fiscal year, and sorts that list from most-cited group to least-cited group. The Industry Profile for OSHA Standard 1910.95 (FY 2009), using the four digit Industry Group NAICS code, was compared to the Industry Profile for OSHA Standard 1910.134 (FY 2009). Six NAICS Industry Group codes were in the top 15 most cited groups for both 1910.95 and 1910.134. This REP covers these six industries as the health hazard list (see Appendix A).

- B. <u>Establishments in Health Hazard Industries</u>. Using the most recently available Dun and Bradstreet employer list prepared by OSHA's Office of Statistical Analysis (OSA), Region VII federal enforcement Area Offices prepared a Master List of establishments using the identified NAICS codes referenced in Appendix A. This list of establishments makes up the health inspection list.
- C. <u>Randomization</u>. The Area Office shall follow procedures and the site randomization protocols outlined in the November 12, 2014, OSHA Memorandum: Establishment Targeting Lists for Emphasis Programs.
- D. <u>Cycles</u>. Each inspection cycle will consist of five establishments from the health inspection list. Completion of each inspection cycle for each list is imperative before generation of another cycle from that list. The CPL 02-00-025, paragraph B.1.b. (1)(e).1, allows establishment carryover to another cycle. Generate subsequent cycles in the same manner using cycles of five establishments each.

### E. Deletions.

- a. Area Offices may delete from the list, any establishment that has received a comprehensive health inspection within the previous thirty-six (36) calendar months of the current inspection cycle.
- b. Area Offices shall apply deletion criteria to the list of establishments, with the exception of deletion criteria H#, I#, S#, and T#, derived from OSHA Instruction CPL 02-00-025, Scheduling System for Programmed Inspections, Paragraph B.1.b.(1)(b)6.d.
- **X. Inspection Procedures.** Inspections will be conducted in accordance with this Instruction and the Field Operations Manual.
  - A. Each establishment scheduled for inspection from the health inspection list, as well as any unprogrammed health inspection or investigation such as a complaint, referral, or fatality in an establishment with a NAICS code in Appendix A, shall receive a comprehensive health inspection as defined by the FOM.
  - B. For **any** unprogrammed safety inspection or investigation such as a complaint, referral, or fatality in **any** establishment with a NAICS code in Appendix A:
    - a. The OSHA Compliance Officer shall conduct sound level meter screenings.
    - b. A referral for a health inspection will occur when sound levels exceed OSHA permissible limits.
    - c. The Compliance Officer shall also assess respirator use and respirator programs for compliance with the respirator standard and propose citation(s) or make a health referral if necessary.
  - C. Area Offices shall schedule reports of imminent danger, fatality/catastrophe, complaints, and referrals as unprogrammed inspections and shall perform

- inspections in accordance with the applicable provisions of the FOM. This does not limit the Area Office's authority to conduct an inspection pursuant to the provisions of the FOM.
- D. <u>Appropriation Act.</u> Area Offices will adhere to OSHA Instruction CPL 02-00-051, Exemptions and Limitations under the Current Appropriations Act, in implementation of this program. Offices will use the most updated list at the time of the opening conference to determine eligibility for inspection.
- XI. OIS Coding. Area Offices will identify Inspections conducted under this REP in the OSHA Information System (OIS) and follow current instructions for completing the appropriate inspection classification boxes on the OIS Inspection Form:
  - A. The OIS Inspection Form for any programmed inspection scheduled under the procedures in this REP shall be marked "Programmed Planned" in the Initiating Type block and the Area Office shall record the word "RESPNOISE" in the Local Emphasis Program block.
  - B. Area Offices shall record "No Inspection" after discovering, at a worksite scheduled for an REP inspection, that an establishment needs deleting from the list (e.g., establishment is out of business, etc.).
  - C. Area Offices will code the OIS Inspection Form for any unprogrammed inspection scheduled under the provisions of the FOM relating to formal complaints, referrals requiring inspection, imminent danger, and fatality/catastrophe investigations as normally required under the FOM. In addition, Area Offices will code the designation of "RESPNOISE" in the Local Emphasis Program block.
  - D. Code placement of "RESPNOISE" is necessary in the Local Emphasis Program field for all consultation activities (i.e., requests, visits, and compliance assistance conducted at establishments in the NAICS codes included in this REP.
- XII. Outreach. At least 90 days prior to commencing inspection activity under this REP, the Regional, and Area Offices previously conducted outreach activities intended to reach as many employers and stakeholders as is practicable. Shortly after the original effective date of this REP, OSHA Region VII distributed a region-wide news release to media. This news release informed affected industries of the existence of this program. In addition, Region VII federal Area Offices make information about this program available during speeches to any audience with possible connections to affected industries.
- **XIII. Program Report.** No later than midway through the life of the program, the Area Office will provide a program report of this REP to the Regional Office. At a minimum, the report should respond to the requirements of CPL 04-00-002, Section VIII, E.
