U.S. Department of Labor Agencies:

U.S. Department of Labor, Office of Disability Employment Policy (ODEP):

ODEP's mission is to develop and influence policies and practices that increase the number and quality of employment opportunities for people with disabilities. To fulfill this mission, ODEP promotes the adoption and implementation of ODEP policy strategies and effective practices, meaning those that ODEP has developed and/or validated, that will impact the employment of people with disabilities. ODEP's approach is to drive systems and practice changes by disseminating ODEP policy strategies and effective practices, sharing information and providing technical assistance to government agencies, service providers and non-governmental entities, as well as public and private employers.

U.S. Department of Labor, Mine Safety and Health Administration (MSHA)

U.S. Department of Labor, Wage and Hour Division:

The Wage and Hour Division (WHD) enforces federal minimum wage, overtime pay,

recordkeeping, and child labor requirements of the Fair Labor Standards Act. WHD also enforces the Migrant and Seasonal Agricultural Worker Protection Act, the Employee Polygraph Protection Act, the Family and Medical Leave Act, wage garnishment provisions of the Consumer Credit Protection Act, and several employment standards and worker protections as provided in several immigration related statutes. Additionally, WHD administers and enforces the prevailing wage requirements of the Davis-Bacon and Related Acts and the Service Contract Act and other statutes applicable to federal contracts for construction and for the provision of goods and services.

U.S. Department of Labor, Occupational Safety and Health Administration (OSHA):

OSHA's mission is to assure America's workers have safe and healthful working conditions free from unlawful retaliation. OSHA carries out its mission by setting and enforcing standards; enforcing anti-retaliation provisions of the OSH Act and other federal whistleblower laws; providing and supporting training, outreach, education, and assistance; and working collaboratively with our state OSHA programs as well as ensuring that they are at least as effective as federal OSHA, furthering a national system of worker safety and health protections.

Directorate of Whistleblower Protection Program (DWPP):

This National Office Directorate supports OSHA's Whistleblower Protection Program which enforces the whistleblower protection provisions under 25 statutes.
